

ORDINANCE 2015-23

An Ordinance to Abolish the Board of Trustees of Public Affairs

Whereas, the Village of South Bloomfield has, by Ordinance 2015-22 created the position of the Village Administrator.

Whereas, pursuant to Ohio Revised Code Section 735.272, upon the lawful appointment of a Village Administrator any Board of Trustees of Public Affairs must be abolished.


Therefore, be it ordained by the Village of South Bloomfield, Pickaway County, State of Ohio, that...

**Section One:** The Board of Public Affairs is hereby abolished effective immediately upon the lawful appointment of a Village Administrator.

**Section Two:** Ordinance 95-14 which established Board of Public affairs is repealed in its entirety. (Ordinance 95-14 attached below)


**Section Three:** This ordinance shall take effect upon passage and remain in full force after the earliest period allowed by law.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO, THAT:

- SECTION 1. The Village Council , do hereby create a Board of Public Affairs, to advise and oversee all affairs, concerning the South Bloomfield Sanitary Sewer System and water system, when developed and completed.
- SECTION 2. Said Board will be composed of three (3) members appointed by the Mayor of said Village, with confirmation by the Village Council.
- SECTION 3. One member will be appointed , to a term to expire on December 31, 1997. Two (2) members will be appointed to a term to expire on December 31, 1999.
- SECTION 4. Said members will be required to run for an additional term of office, when said appointed term has expired.
- SECTION 5. Said members will be paid the set fee of \$25.00 per meeting.
- SECTION 6. Said ordinance is in effect and agreement with the Ohio Revised Code ( 735.28)
- SECTION 7. This ordinance will be declared as an emergency measure and passed accordingly.
- SECTION 8. Effective date of ordinance will be at once.
