

ORDINANCE 2015-25

An Ordinance to abolish the position of Street Commissioner

Whereas by establishing the position of Village Administrator the Street Commissioner is no longer necessary.

Therefore, be it ordained by the Village of South Bloomfield, Pickaway County, State of Ohio, that...

**Section One:** The Position of Street Commissioner is hereby abolished

**Section Two:** Ordinance 2014-10 which established Street Commissioner is repealed in its entirety. (Ordinance 2014-10 attached below)

**Section Three:** The powers and duties of the Street Commissioner are not the powers and duties of the Village Administrator.

**Section Four:** This ordinance shall take effect upon passage and remain in full force after the earliest period allowed by law.

ORDINANCE 2014-10

AN ORDINANCE REPEALING AND REPLACING ORDINANCES 95-07 AND 87-05 OF THE VILLAGE OF SOUTH BLOOMFIELD, PERTAINING TO THE POSITION OF STREET COMMISSIONER

WHEREAS, IT HAS BECOME NECESSARY TO CLARIFY AND REPEAL PRIOR ORDINANCES SETTING THE SALARY AND DESCRIPTION OF STREET COMMISSIONER DUTIES

THEREFORE, BE IT ORDAINED BY THE VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO, THAT

SECTION 1: ORDINANCE NUMBER 95-07, PASSED ON FEBRUARY 21, 1995, IS HEREBY REPEALED IN ITS ENTIRETY.

SECTION 2: ORDINANCE NUMBER 87-05, PASSED ON JANUARY 19, 1987, IS HEREBY REPEALED IN ITS ENTIRETY.

SECTION 3: THE VILLAGE OF SOUTH BLOOMFIELD ESTABLISH A SALARY FOR THE STREET COMMISSIONER

SECTION 3: SAID SALARY WILL BE AT A RATE OF \$100.00 PER MONTH, PAID MONTHLY DURING THE LAST PAY PERIOD OF EACH MONTH

SECTION 4: SAID STREET COMMISSIONER MUST ATTEND ANY SCHEDULED STREET COMMITTEE MEETINGS

SECTION 5: SAID STREET COMMISSIONER WILL SUBMIT A REPORT TO THE FIRST COUNCIL MEETING EACH MONTH ON CONDITIONS OF PARKS, STREETS, CURBS, GUTTERS, SIGNS, TRAFFIC LIGHTS AND TRAFFIC PROBLEMS CONCERNING THE STREETS AND ALLEYS IN THE VILLAGE

SECTION 6: SAID STREET COMMISSIONER WILL OVERSEE STREET OPERATIONS, MAINTENANCE OF THE PARKS, MAINTENANCE OF ALL BUILDINGS OWNED BY THE VILLAGE, AND MAINTENANCE OF VILLAGE OWNED VEHICLES.

SECTION 7: THIS ORDINANCE SHALL TAKE EFFECT UPON PASSAGE AND REMAIN IN FULL FORCE AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
