Whereas by changing the status of the park commissioner to volunteer status the village will save \$900.00 annually.


Whereas the current Park Commissioner has repeatedly asked to not be paid for the position of Park Commissioner and use those funds on the park.


Therefore, be it ordained by the Village of South Bloomfield, Pickaway County, State of Ohio, that...

Section One: The Position of Park Commissioner is hereby designated a Volunteer Status position with a compensation of \$0.00 annually.


Section Two: Ordinance 2014-09, which established Park Commissioner, is repealed in its entirety. (Ordinance 2014-09 attached below)

AN ORDINANCE REPEALING ORDINANCE 91-01 AND ESTABLISHING A PARK COMMISSIONER OF THE VILLAGE OF SOUTH BLOOMFIELD

WHEREAS, ORDINANCE 91-01 REPEALED THE POSITION OF PARK COMMISSIONER

REPEALED

WHEREAS, IT HAS BECOME NECESSARY TO HAVE A POSITION TO OVERSEE GENERAL PARK DUTIES

WHEREAS, IT HAS BECOME NECESSARY TO DESCRIBE THE DUTIES OF SAID POSITION AND PROVIDE A SALARY

THEREFORE, BE IT ORDAINED BY THE VILLAGE OF SOUTH BLOOMFIELD, PICKAWAY COUNTY, STATE OF OHIO, THAT

SECTION 1: ORDINANCE NUMBER 91-01, PASSED ON JANUARY 7, 1991, IS HEREBY REPEALED IN ITS ENTIRETY.

SECTION 2: THE VILLAGE OF SOUTH BLOOMFIELD ESTABLISHES A POSITION, SALARY, AND DUTIES OF PARK COMMISSIONER

SECTION 3: SAID SALARY WILL BE AT A RATE OF \$100.00 PER MONTH FOR 9 MONTHS ONLY (RUNNING FROM MARCH TO NOVEMBER), PAID MONTHLY DURING THE LAST PAY PERIOD OF EACH MONTH

SECTION 4: SAID PARK COMMISSIONER WILL WORK WITH THE DIRECTION OF PARK COMMITTEE AND MUST ATTEND ANY SCHEDULED PARK COMMITTEE MEETINGS

SECTION 5: SAID PARK COMMISSIONER WILL SUBMIT A REPORT TO THE FIRST COUNCIL MEETING EACH MONTH ON CONDITIONS OF THE PARK AND ANY ISSUES WITH THE PARK

SECTION 6: SAID PARK COMMISSIONER WILL OVERSEE SCHEDULING OF FACILITIES AND ACTIVITIES, PROVIDING ACCESS TO RESTROOM FACILITIES DURING SCHEDULED TIMES, CLEANING RESTROOM FACILITIES AFTER SCHEDULED TIMES, NOTIFYING VILLAGE OFFICE OR MAYOR OF ANY DAMAGE

SECTION 7: THIS ORDINANCE SHALL TAKE EFFECT UPON PASSAGE AND REMAIN IN FULL FORCE AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
