

Ordinance 2016-09

An ordinance to repeal and replace Ordinances 2000-11 and 2000-15 Municipal Motor Vehicle Tax

Whereas the appropriations for street maintenance received from the State of Ohio has not increased and,

Whereas the cost associated with maintaining and improving the streets in the village has increased,

Therefore be it ordained by the Council for the Village of South Bloomfield, Pickaway County, State of Ohio

Section 1 Ordinance 2000-11 Levy Municipal Vehicle License Tax and Ordinance 2000-15 Amending Ordinance 2000-11 are hereby repealed and replaced.

Section 2 Section 4504.172 of the Ohio Revised Code states that:

For the purpose of paying the costs and expenses of enforcing and administering the tax provided for in this section; to supplement revenue already available to municipal corporations under section 4504.04, 4504.06, 4504.17, or 4507.171 of the Revised Code, and to provide additional revenue for the purposes set forth in those sections, the legislative authority of any municipal corporation may levy an annual license tax, without regard to any tax being levied pursuant to section 4504.06, 4504.17, or 4504.171, or received pursuant to section 4504.04 of the Revised Code, and in addition to the tax levied by sections 4503.02, 4503.07, and 4503.18 of the Revised Code, upon the operation of motor vehicles on the public roads or highways. The tax shall be at the rate of five dollars per motor vehicle on all motor vehicles the district of registration of which, as defined in section 4503.10 of the Revised Code, is in the municipal corporation levying the tax, and shall be in addition to the taxes at the rates specified in sections 4503.04 and 4503.16 of the Revised Code, subject to reductions in the manner provided in section 4503.11 of the Revised Code and the exemptions provided in sections 4503.16, 4503.17, 4503.171, 4503.41, and 4503.43 of the Revised Code.

No ordinance, resolution, or other measure levying a municipal motor vehicle license tax pursuant to this section shall be enacted as an emergency measure under section 731.30 of the Revised Code or pursuant to the charter of any municipal corporation and each such ordinance, resolution, or other measure is subject to a referendum as provided in sections 731.29 to 731.41 of the Revised Code or by the charter of the municipal corporation.

A municipal motor vehicle license tax levied under this section shall continue in effect until repealed.

Effective Date: 07-01-1987

Section 3 There is hereby levied an annual tax upon the operation of motor vehicles on the public roads or highways pursuant to section 4504.172 Ohio Revised Code for the purpose of paying the cost and expenses of enforcing and administering the tax provide additional revenue for the purposes set forth in 4504.06 Ohio revised code and to supplement revenue already available for such purposes.

Section 4 Such tax shall be at the rate of five dollars (\$5.00) per motor vehicle on each and every motor vehicle whose registration as defined in section 4505.10 of the Ohio Revised Code, is the Village of South Bloomfield, Ohio.

Section 5 As used in this ordinance the term "motor vehicle" means any and all vehicles included within the definition of motor vehicle in sections 4501.01 and 4505.01 of the Ohio Revised Code.


Section 6 The tax imposed by this ordinance shall apply to and be effective for the registration year commencing January 1, 2017 and shall continue in effect and application during each registration year thereafter.

Section 7 The tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio or to a Deputy Registrar at the time application for registration of a motor vehicle is made as provided in section 4503.10 of the Ohio Revised Code.

Section 8 All monies derived from the tax levied shall be used by the Village of South Bloomfield for the purposes specified in this ordinance.

Section 9 This ordinance shall take effect upon passage and remain in full force after the earliest period allowed by law.
