

**ORDINANCE 2017-10**

AN ORDINANCE FOR ADDITIONAL FUNDS RECEIVED FROM OHIO ATTORNEY GENERAL'S OFFICE FOR OHIO POLICE OFFICERS TRAINING SERVICES.

WHEREAS IT HAS BECOME NECESSARY TO AMEND CERTIFICATE OF RESOURCES FOR 2017 TO REFLECT RECEIPT OF \$2,640 AND DECLARING AN EMERGENCY TO DO SO;


